- Upon receipt, the Red Light Camera Program will review your Affidavit of Non-Liability then submit a Request for Dismissal to the Carol Miller Justice Center (The Court).
- You will be contacted by mail if a Request for Dismissal IS NOT submitted.
- You may contact the Red Light Camera Program office 14 days after you return the Affidavit of Non-Liability to confirm receipt and status.
- You should contact the Carol Miller Justice Center 30 days after returning the Affidavit of Non-Liability to confirm acceptance of the Request for Dismissal. 6.
- If the court rejects the Request for Dismissal, you will need to contact the Carol Miller Justice Center for further directions.

DO NOT PAY THE FINE, ARRANGE TRAFFIC SCHOOL OR SET A COURT TRIAL IF YOU ARE NOT THE DRIVER. Follow the above directions or contact the Red Light Camera Detail office at 916-876-6643, if you have any questions.
